## **CONDITIONS**

- a) If the premises described in clause 1 hereof shall be temporarily or permanently used or any performances or entertainments different in number or type from those on the basis of which this Licence-Contract has been entered into, the permission granted hereunder by the Society shall not extend to or be deemed to authorise such different performances or entertainments, unless and until the appropriate royalty in respect thereof shall have been paid pursuant to clauses 2 and 3 hereof.
- b) The Licensee shall not assign or part with the possession of this Licence-Contract without the previous consent in writing of the Society.
- c) The Society, by its duly authorised agent, shall have the right of free entry in and upon the premises during all times of public performance, but solely for the purpose of checking the particulars on which the royalty under this Licence-Contract is calculated.
- d) The Licensee shall, while the Licence-Contract remains in force, furnish the Society on forms which will be provided by the Society with such particulars of the musical works publicly performed on the premises pursuant to this Licence-Contract as are reasonably required to enable the royalties paid hereunder to be distributed to the parties interested in those works.
- e) If the Licensee shall commit any breach of the provisions or conditions hereof, or fail to make any payment herein provided, or to comply with any other terms of this Licence-Contract, on the day herein named or thereafter within seven days from the date of any demand for payment or compliance, the Society may, notwithstanding anything hereinbefore expressed to the contrary, forthwith determine this Licence-Contract by written notice sent by registered post to the Licensee at the address given herein, and thereupon this Licence-Contract shall determine save as to the right of the Society to recover any monies previously due hereunder.
- f) Subject to the due observance by the Licensee of the provisions of the Licence, the Society agrees to indemnify the Licensee, its servants or agents from all claims and suits for copyright infringement that may be brought against it or any of them in respect of the public performance (excluding that for sound recordings), as referred in the Licence hereto, by the Licensee of musical works within the Society's repertoire or represented by the Society to the Licensee as such. The Society further agrees to indemnify the Licensee its servants and agents in respect of all reasonable legal costs incurred by it or them in defending such actions or suits which may be brought against it or them as aforesaid PROVIDED THAT the Licensee shall promptly notify the Society of such actions or suits and shall permit the Society to conduct the defence thereto in the name of the Licensee.
